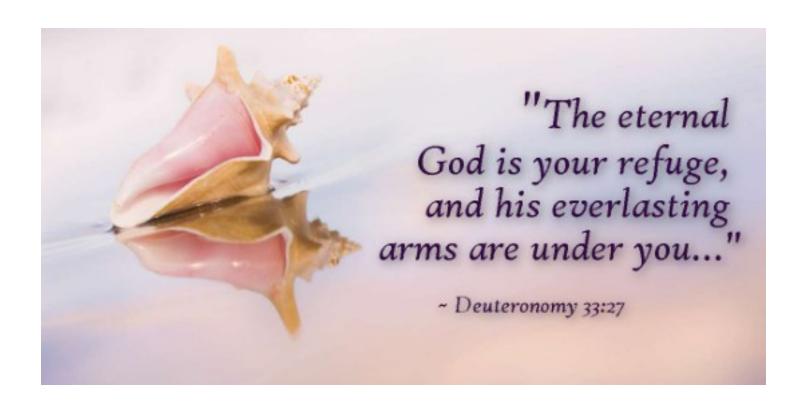

Dear Friends,

This past year was a year of collaboration and joining with others. We joined with First Pres Elmira and others for their Maundy Thursday service. Over the summer, First Pres Horseheads joined us here for two worship services and on Sunday, July 21, all four of the local Presbyterian congregations were here for VBS Sunday. We went to First Pres Elmira for World Communion Sunday and to Horseheads in December for a Christmas Cantata worship service.

It was not just worship services either. We collaborated with First Pres Elmira with Vacation Bible School. In February, with the closing of their long-time food pantry, folks from New Beginnings UMC joined our food pantry. The new volunteers allowed us to reopen on Mondays. These partnerships have helped us and helped our partners in our joint mission and outreach to our community.

One of the biggest things we did this year was the hosting of Matsiko World Orphans Choir, not once, but twice. The first time we did it, it was with very short notice, and we did most of the work to host them. The second time though, with the considerable help, time, talents, and connections of others, we were able to bring together multiple congregations, organizations, and even Elmira College to host the choir. What a joy it was to see the Gibson Theatre on Elmira College's campus filled with people from all over Elmira and the surrounding communities. You, we, all had a part in making that happen.

I do not know what this upcoming year will bring, but I am convinced that the Holy Spirit will be with us, will guide us, and if we listen and follow, lead us in new and exciting ways to serve and love our neighbors. I, for one, cannot wait to see what happens.

Commissioner to Presbytery of Geneva

Presbytery Report

Our congregation continues to be very involved in the Presbytery of Geneva. In 2024, Elder Jeff Richards served as the Chair of General Council, thus completing a three-year commitment in which he served as Vice-Moderator of the Presbytery, then Moderator of the Presbytery, and finally as the Chair of General Council. He also served his final year as a member of the Camp Whitman Committee after having served on that committee for several years.

I continue to also be involved in the Presbytery of Geneva. At the end of 2024, I rotated off of the Operations Committee and began a new role as the Vice-Moderator of the Presbytery. I continue to serve on the Committee for Preparation of Ministry, and I am a member of the Presbytery's General Council. In addition to participating in the Presbytery of Geneva, I am a member of the Synod of the Northeast's Permanent Judicial Commission, and I serve on the Synod's Small Church Residency Review Team.

In December 2024, our congregation reached an agreement with the Presbytery of Geneva to provide administrative support services to the Presbytery. This agreement has made it possible for our congregation to make our church administrator, Gretchen Duffy, a full-time employee and provide her with health insurance benefits.

Our per capita and mission contributions help fund Camp Whitman, mission projects throughout our presbytery, workshops, and trainings, and assist the presbytery to prepare for a future in which our presbytery and others work together to collaborate and combine resources to support our congregations.

I want to thank Elder E. Annie LeFevre for the dedication and enthusiasm she brings to being our Ruling Elder Commissioner to Presbytery.

2024 – A Year of Quietness for a change

2024 was a year of being fairly quiet in and around our buildings and grounds!

Tech Booth Update: We will need to replace our soundboard in the near future. We are still continuing zoom and recording sermons. We are contemplating adding a bigger screen to the narthex by the Brisbane room. This would allow us to remove the smaller TV from above the closet door so it can be more comfortable to see and read.

Finance Committee Annual Report 2024

The finance committee members were Janice Williams, Phil Carpentier, Linda Palmer, cochair Joel Robinson and Treasurer Pat Richards. The committee met eleven times in 2024.

In addition to reviewing the financial reports each month the committee also manages the churches endowment. The endowment has performed well again this year under management by Chemung Canal Trust. The committee continues to have the endowment invested conservatively limiting fluctuations in value by investing in funds as opposed to individual stocks.

The committee recommended to session that a custodial account also be opened this year. This account allows us to invest funds sitting in a low interest savings account and receive a higher rate of return. With the treasurer monthly reports were changed to better reflect expenses and how funds move through the church's budget.

The committee is also responsible for the annual stewardship campaign. This year we delayed our appeal until we had the budget approved. We continue to use the endowment to fund the majority of our budget which is a blessing. The continued support of pledging members is still vitally important to allowing the breadth and impact of North Presbyterian's mission.

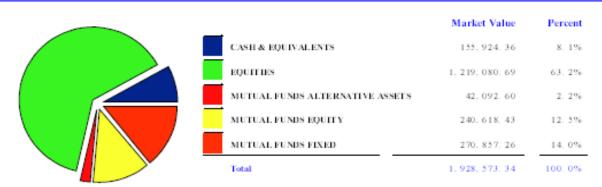

FOOD PANTRY 2024

"Whoever is kind to the poor lends to the Lord, and He will repay them for what they have done." (Proverbs 19:17)

Could you feed yourself for three days on \$4.17?

Think about that. Three meals for three days -9 meals -6 for about \$4.17. That is less than \$0.50 per meal.

This church did that for 9,391 people in 2024, through the NPC food pantry. Our total cost for food, excluding what was covered by grants, was \$39,145.80. Feeding 3,378 families last year, an almost 50% increase from 2023, was a blessing that NPC provided to the hungry in our community.

Can we continue to do that in 2025? Unfortunately, numbers don't lie. We spent a total of \$44,472.47 in 2024 on food, bags, personal needs products and supplies. We received donations of \$23,014.69. We are running at a deficit, and as demand continues to grow, we will continue to do that.

In 2024, the food bank that New Beginnings had run for many years closed and they joined us here at North. They brought volunteers, equipment, food, financial support, and enthusiasm. As a result, we were able to reopen on Mondays from 10 to noon.

Our donors and volunteers have been more than generous with their money and time. We also have worked to cut spending, by eliminating the personal needs program, not ordering more expensive products (such as butter) and taking advantage of the grant money and free products offered through the Food Bank of the Southern Tier.

Organizations and individuals that helped in this mission include: Wegman's, Weis, Panera Bread, Haskins Gardens, Westside United Methodist Church, Pine City Baptist Church, New Beginnings, Park Church, Arnot-Ogden Hospital, Arnot-Ogden Food Service, LECOM gardeners, First Presbyterian Church, Elmira, Thursday Morning Musicales, Ladies of Charity, Orchestra of the Southern Finger Lakes, Ladies of the Ancient Order of Hibernians, the Elmira Disc Center, Tom Petzke and Yoga.

Fresh produce came from local gardeners, including Kevin Kamas, Gretchen and John Duffy, Kate and Evan Hansen and Jeff Richards (from our own Pantry Patch).

Our dedicated volunteers also gave generously, supplying plenty of items to fill shelves and many hours out of their day to serve customers with respect and compassion.

The Mission Committee worked quietly behind the scenes in 2024, supporting missions throughout the community and the world.

Once again, Missions generously donated \$12,000 to help the North Presbyterian Church Food Pantry in its work to feed the hungry. Missions also supported the Community Kitchen, Renovation House, Second Place East and Presbytery Mission.

Two Honduran children – Eliezer Daniel Pena Perez and Jeferson Aaron Cruz Alvarez – were able to receive school supplies and school uniforms through Missions participation in the Border Buddies school sponsorship program. That aid will continue this year, as the children move up into 8th and 5th grade.

Missions supported Presbyterian efforts in the wider world by sponsoring four offerings:

Peace and Global Witness; \$342 was collected, of which 25% stays in our community to support local peacekeeping efforts;

One Great Hour of Sharing; almost \$725 was donated;

Pentecost; NPC keeps 40% of the \$1,195 collected to support programs for youth in our community;

Christmas Joy offering received \$382 in donations.

In 2025, the Missions Committee will continue to search for ways to help and heal people in our community, our country and our world.

Annual Staff Evaluations for 2023 in January/February 2024 were written by Pastor Hansen and members of the congregation, then reviewed with staff members.

The Sick and Safe Leave policy was updated to comply with new NY State policy requirements.

Pastor Hansen negotiated an agreement to provide contract services by our office Administrator, Gretchen Duffy, as Administrative Support to Geneva Presbytery. She will provide those services to the Presbytery remotely from her current office at NPC. This is definitely a win for us, the Presbytery and for Gretchen. For us, it allows our church to have our Office Administrator present Monday through Friday. For Presbytery, they were finding it difficult to find a qualified person willing to work 15 hours per week. This makes Gretchen a full-time employee of North Presbyterian Church. Yearly salaries were reviewed and recommendations made to Session regarding compensation for 2025.
